On July 2, 2026 the issuer announced that it had started its inaugural field program for the Yath Project, Kivalliq Region, Nunavut. On July 3, 2026 the issuer announced a non-brokered flow-through private placement of up to \$350,000 at \$0.09 per unit to fund eligible Canadian critical mineral exploration expenses at its Yath uranium project in Nunavut. On July 9, 2026 the issuer

announced its participation in the Emerging Growth Conference on July 15, highlighting ongoing exploration at its Yath Project and increased its flow-through private placement to \$400,000. The issuer announced on July 17, 2026 that it had received conditional approval to list on the CSE and voluntarily delist from the TSX Venture Exchange to reduce costs, while postponing its \$400,000 flow-through financing until after the CSE listing. On July 21, 2026 the issuer highlighted Atha Energy's nearby uranium discovery at the Angilak Project, noting it validates and enhances exploration targets on Generation's adjacent Yath Project in Nunavut. On July 22, 2026 the issuer announced its common shares were approved for listing on the Canadian Securities Exchange under the symbol GEN, with trading commencing on July 24, 2026. On July 28, 2026 the issuer announced that it had closed its non-brokered flow-through private placement, raising \$361,072 through the issuance of 4,011,921 units at \$0.09 per unit to fund eligible Canadian exploration expenses.
